Re: Granting Subject-wise Exemption in Insurance Institute of India's qualification to the qualification of PGDM- Banking, Insurance, Finance and Allied Services (BIFAAS) Program from Siva Sivani Institute of Management - Kompally, Secunderabad.

Please refer to your letter dated 13<sup>th</sup> April, 2016 regarding proposal for accreditation of **PGDM-Banking, Insurance, Finance and Allied Services (BIFAAS) Program offered by your institute** for credits for prior learning in Professional examinations of Insurance Institute of India.

We are pleased to inform you that the Board of Education of Insurance Institute of India has agreed to grant the subject wise/paper wise exemption to the candidates who have passed the PGDM-Banking, Insurance, Finance and Allied Services (BIFAAS) Program from Siva Sivani Institute of Management – Kompally, Secunderabad.

The subject wise/paper wise exemption will be available for III's Licentiate qualification.

A. The subjects considered for exemption are as under. Candidates are not allowed to appear these subjects of III.

Sr. No.	Subjects / Syllabus of III
1	IC 01 – Principles of Insurance
2	IC 02 – Practice of Life Insurance
3	IC 11 – Practice of General Insurance

**B.** As per the decision, 60 credit points will be granted to the candidates acquiring above qualification of PGDM- Banking, Insurance, Finance and Allied Services (BIFAAS) from Siva Sivani Institute of Management – Kompally, Secunderabad.

The c iteria, terms and conditions for granting exemption are as under:

- i. The Candidates should have passed the above qualification with a minimum of 50% marks in each subject in their first attempt. The assessment of these papers shall be done by the university/college as per the prevailing standards and procedures.
- ii. The candidate has to then register as a member of III by paying registration fees which at present is Rs.700/- along with applicable service tax in force from time to time.
   Candidate can register and pay the registration fees along with the applicable service tax at III web site. <a href="https://www.insuranceinstituteofindia.com">www.insuranceinstituteofindia.com</a>

## Steps to be followed while registering as a member of III (One time process)

- 1. Create an account (login ID) on III web site and get (login ID, Password) details.
- 2. Note down login details.
- 3. Sign in (login in) with login ID password.
- 4. Click on Profile under Registration menu and fill up details.
- 5. Note down candidate Id generated by the system.
- 6. Upload photograph (\* Note Photograph Size Height 152, width 133, size up to 25 KB with (.jpg) extension.
- 7. Click on Registration and pay fee online.
- 8. Detailed Help is available on Home page under Help Desk Menu.
- iii. After registering as a member of the institute as above, the student then shall apply for exemption in the prescribed proforma which is enclosed here with. (It is also available in downloadable form at our website under **Examinations menu Certificate/Diploma examinations Exemptions.)**
- iv. For claiming exemption the candidate shall have to produce copy of certificate/mark sheet of having acquired the above qualification duly attested by respective head of the department /University along with covering letter and send it to Insurance Institute of India Examination Department.
- v. The candidate requires to pay the exemption fees according to fees structure available at III web site plus the applicable service tax as per the rules of the Institute in force from time to time through Demand Draft in favour of "Insurance Institute of India".
- vi. The Institute shall then examine the request and award 60credit points and issue a certificate of having successfully passed the Licentiate Examination.
- vii. Subject wise Credit Points will be granted to the candidates only if they apply and register for III examination within 5 years from passing their above qualifying examination.
- viii. The exemption is granted for a period of 3 years. Same will be reviewed after completion of 3 years.
