Kompally, Secunderabad, Andhra Pradesh.

Sir,

I am directed to state that based on the recommendations of the All India Board of Management Studies of the Statutory AICTE at its Meeting held on 16-9-1992, the AICTE has accorded approval to the Siva Sivani Institute of Management at Kompally, Secunderabad under the aegis of Siva Sivani Education Society, Secunderabad for conduct of the 2-year full-time PG diploma course in Management with a total intake of 40 (Forty) for one year during 1992-93 only:-

This approval is subject to fulfilment of the following conditions:-

- 1) Adequate class-room facilities such as seating arrangements and acoustics etc should be provided. The number of rooms should be readjusted to the needs of the programme.
- 2) The library should be provided with additional professional National and International journals in Management Education.
- 3) The Institute should procure Educational Video films on various Management subjects.
- 4) The faculty should be augmented to cover all disciplines uniformly.
- 5) The Management of the College including the Governing Council should be constituted as per the guidelines of the AICTE.
- 6) All admissions should be made as per the norms and guidelines of the AICTE and as adopted by the State Government of Andhra Pradesh.
- 7) The tuition and other fees should be charged as prescribed by the State Government within the overall criteria prescribed by the AICTE from time to time. No capitation fees should be charged from the students/ guardians of the students in any form.

- 8) The accounts of the Institute should be audited by a Chartered Accountant and should be open for inspection by the AICTE or anybody authorised by it.
- 9) The teaching and other staff should be recruited according to the procedure, guidelines and experience prescribed by the AICTE.
- 10) No new course should be started without the prior approval of the AICTE.
- 11) The intake in any of the approved course should not be altered under any circumstances without the prior concurrence of the AICTE.

The Management should strictly follow any further conditions as may be laid down by the AICTE from time to time.

The Siva Sivani Institute of Management Sciences, Kompalli should submit a duly registered undertaking to the AICTE, Delhi by January 31, 1993 confirming its willingness to fulfil the general conditions laid down by the AICTE.

In the event of non-compliance by the Trust or the Institute with the above conditions of the AICTE, the AICTE will be free to take measures for withdrawal of its approval without consideration of any related issues and that all the consequent liabilities would be that of the Trust and/or the Institute.

An Expert Committee of the All India Board of Management Sciences - AICTE - will visit the Institute by the end of the academic year 1992-93 to review the progress made in fulfilling the conditions laid down by the AICTE and recommend continuation of the AICTE approval or otherwise.

Extension of this approval for the next academic year will be subject to satisfactory compliance with the conditions stated above.

You are requested to kindly take appropriate action to implement the decision of the AICTE and communicate the progress made in this regard to the Southern Regional Office of the AICTE under intimation to this Office.
