In view of the directions of the Hon'ble Supreme Court SLP No. 24295 of 2006, dated. 16th May, 2007 and in Civil Appeal number 887 of 2009 dated. 08th May, 2009, Siva Sivani Institute of Management has constituted the Anti Ragging Committee.

ANTI RAGGING COMMITTEE

Anti-Ragging Committee will ensure compliance with the provisions of the Regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution. As per the order of Supreme Court of India, ragging constitutes one or more of any intention by any student or group of students on:

- Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origin, linguistics, identity, place of birth, place of residence or economic background.
- Any act of teasing or handling with rudeness.
- Any activity which is likely to creates fear or apprehension.
- Any Act of physical abuse causing assault, harm or danger to health.
- Any Act of abuse by spoken words, emails, SMS or public insult etc.
- Any unlawful assembly or conspiracy to ragging.

Punishment for the guilty

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments:

- Debarring from appearing in some or all Internal or Term-End Examinations
- Suspension from attending classes and academic privileges
- Withdrawing scholarships and other benefits
- Suspension from the college for a stipulated period as decided by the Committee

Objectives of Anti Ragging Committee

Anti-Ragging Committee responsible for inculcating Culture of Ragging Free Environment in the Campus. The Anti-Ragging Squad office bearers will work under the Supervision of Anti Ragging Committee and

to engage in the works of checking places like Hostels, Buses, Canteen, Classrooms and other places of student congregation. Anti-Ragging Committee will be involved in designing strategies and action plan for curbing the Menace of Ragging in the college by adopting array of activities. The Committee also would conduct awareness programmes from time-to-time in the campus.
